\$250 POWER BONUS

The Victorian Government has announced a new round of its \$250 Power Saving Bonus. Applications opened on 24 March and will remain until 31 August 2023.

The Power Saving Bonus is available to all Victorian households – no concession card needed!

To claim the bonus — a once-off payment per round — visit the Victorian Energy Compare website. You will need a recent electricity bill that names you as an account holder. The \$250 payment is made directly into your nominated bank account and can be used however you wish. The Bonus is limited to one payment for each eligible household.

If you need help to apply, try a friend or family member – If someone you know has a computer with the internet, ask if you can use it to visit "Victorian Energy Compare" website.

FAIRY BREAD JELLY SLICE



INGREDIENTS:

2 x 165g packets white chocolate Tim Tams.

1/3 cup desiccated coconut.

100g butter, melted, cooled.

395g can sweetened condensed milk.

1/2 cup lemon juice.

2 tsp gelatine powder.

2/3 cup boiling water.

1/4 cup bright sprinkles, plus extra, to decorate.

Jelly topping

85g packet Aeroplane Jelly Creaming Soda.

1 cup boiling water.

1/2 cup cold water.

Step 1

Grease an 18cm x 28cm slice pan. Line base and sides with baking paper, extending paper 2cm above edges of pan.

Step 2

Place biscuits and coconut in a food processor. Process until fine crumbs. Add butter. Process until combined. Press mixture evenly over base of prepared pan. Refrigerate for 10 minutes.

Step 3

Whisk condensed milk and lemon juice together in a bowl. Sprinkle gelatine over boiling water. Whisk with a fork to dissolve. Stand for 2 minutes. Gradually whisk into milk mixture until combined. Stand for

3 to 4 minutes to cool. Fold in sprinkles. Pour over prepared base. Refrigerate for 2 hours or until set.

Step 4

Meanwhile, place jelly crystals into a heatproof jug. Add boiling water. Stir until crystals have dissolved. Stir in cold water. Set aside for 1 hour to cool to room temperature.

Step 5

Gently pour jelly over slice. Refrigerate for at least 3 hours or until set.

Step 6

Carefully remove slice from pan and cut into pieces. Decorate with extra sprinkles. Serve.
